GUIDELINES FOR SELLING / EXHIBITING

- i) THE PRODUCT(S) OFFERED FOR SALE MUST BE HORTICULTURE RELATED INCLUDING OUTDOOR LIVING PRODUCTS AND SERVICES. SOME ACCEPTABLE PRODUCTS INCLUDE: HARDSCAPES, STEPPING STONES, YARD ART, OUTDOOR / PATIO CANDLES, BARBECUES (GRILLS, SMOKERS), HYDROPONIC GARDENING, PATIO HEATERS, PATIO FURNITURE & ACCESSORIES, OUTDOOR SPAS, FENCING / DECKING, LIVE PLANTS FOR INDOOR & OUTDOOR USE INCLUDING CUT FLOWERS, HORTICULTURE RELATED BOOKS & MAGAZINES, CLOTHING / ACCESSORIES FOR GARDENING, SUNROOMS / SOLARIUMS / SKYLIGHTS, SUN PROTECTION PRODUCTS, GARDEN / HORTICULTURE SOCIETIES, HORTICULTURE RELATED COMPUTER SOFTWARE, FLORAL / LANDSCAPE ART PIECES, HERBS, SPICES, DRY FLOWERS, SASK MADE EDIBLES, FRUIT PROCESSED IN SASKATCHEWAN, FRUIT GROWERS, MEAT PRODUCED IN SASKATCHEWAN, SASKATCHEWAN COMMODITY GROUPS ie: MUSTARD, CANOLA, FLAX, PULSES, SOURCES OF GREEN ENERGY (SOLAR, WIND, GEOTHERMAL)
- ii) SASKATOON PRAIRIELAND PARK RESERVES THE RIGHTS TO ALL FOOD AND BEVERAGE CONCESSION SALES FOR IMMEDIATE CONSUMPTION. FREE SAMPLING IS PERMITTED.
- iii) THE SALE OF RAFFLE OR LOTTERY TICKETS IS NOT PERMITTED, WITHOUT PRIOR APPROVAL. MEMBERSHIP SALES ARE LIMITED TO HORTICULTURE AND GARDEN CLUBS & SOCIETIES.
- iv) EXHIBITORS WHO ARE SELLING PRODUCT MUST HAVE SUFFICIENT STOCK ON HAND SO THEY DO NOT SELL THEIR DISPLAY MATERIALS. DISPLAY MUST REMAIN INTACT UNTIL CLOSE OF SHOW.
- v) SASKATOON PRAIRIELAND PARK AND GARDENScape COMMITTEE RESERVES THE RIGHT TO REJECT ANY EXHIBITOR APPLICATION RECEIVED IN WHOLE OR IN PART. APPLICANTS WILL BE REVIEWED ANNUALLY.
